## Eligibility

Artist must be 16 years of age or older.

Open to all media, entries must be original, entirely the work of the entrant, executed within the last three years, and without the supervision of an instructor.

## Conditions

Entries will be juried from the original works of art delivered to the gallery. Works in 2 and 3 dimensions including photography and jewelry are accepted. No work may exceed 50" in width (including frame for two-dimensional work).

All two-dimensional works on paper must have glass or plexiglass. Work must be sturdily framed and ready to hang, including wire. Presentation will be a factor in selection.

Artists having all submissions **accepted** will be **notified by phone**. If you are not called, **please pick up your art work by February 29** — 10 AM to noon

## Entries

A maximum of 5 entries may be submitted.

**Fees:** \$20 for first entry, \$5 for each additional entry; NAA Donors \$15 for first entry, \$5 for each additional entry. All fees are non-refundable.
