Eligibility

Alchemy of the Abstract VIII is open to all media, entries must be original, entirely the work of the entrant, executed within the last three years, and without the supervision of an instructor.

Conditions

Entries will be juried from the actual 2- or 3-dimensional works of art. No work shall exceed 50" in width including frame or mount. Open to all media including jewelry.

All hanging artwork must be suitably framed or wrapped canvas and ready to hang with wire, not saw tooth hangers. Presentation will be a factor in selection.

Artists having all submissions **accepted** will be **notified by phone**. If you are **not called, please pick up your art work** by **May 31** –10 AM to 2 PM

Entries

A maximum of 5 entries per person may be submitted. Completed labels must be attached to back upper right corner of framed pieces and the base of 3-dimensional work. All 2-dimensional works on paper must have surface protection.

Fees: \$25 for first entry, \$5 for each additional entry. All fees are non-refundable.

Should your work(s) sell, Northwind Arts Center will pay a wholesale price equal to 60% of the retail-selling price. Price is set at time of submission.

Juror

Jonathan Wood: Originally from the East Coast, Jonathan moved to Seattle in 2002 to attend a Master's program in Art History at University of Washington where he focused on contemporary Northwest Coast Native American art. While in school, Jonathan started an internship with a local gallery. He eventually became director of that gallery, before acquiring it in January 2012 and rebranding it as Abmeyer + Wood. Jonathan is passionate about many art forms but has a special place in his heart for abstract expressionist painting and figurative sculpture.
